



GENERAL SCHOLARSHIP INFORMATION

1. Applicant must be an Olgoonik Corporation shareholder or descendant of a shareholder (subject to verification) who is at least 17 years of age and a U.S. citizen.
2. This scholarship is provided to students who seek college or university education.
3. This scholarship is provided for students who are enrolling or currently enrolled in an approved college or university and are working toward a degree or certificate that can be useful in their future.
4. Scholarship retention will be evaluated at the end of each term or grading period and will be based on student performance against the requirements as described below.
5. The maximum funding level during an academic year is up to \$9,000 and a maximum lifetime total of up to \$24,000 per recipient. Funding received under the Olgoonik Foundation Training Program counts towards funding caps.

LEVELS OF FUNDING FOR DEGREE PROGRAMS

Olgoonik Foundation scholarship recipients who maintain eligibility can receive up to a maximum of \$9,000/ year for certificate and undergraduate degree programs or up to \$12,000/year for graduate degree programs, up to a lifetime total of \$24,000 in scholarship funding, disbursed on a term-by-term basis. Funds are distributed on a per-credit basis and scaled to meet undergraduate program tuition costs by quarter or semester or graduate program tuition costs by semester.

ACADEMIC REQUIREMENTS AND TERMS FOR ALL FUNDING LEVELS:

Scholarship recipients must maintain a 2.0 Grade Point Average (GPA) or equivalent in order to continue receiving scholarship funding. A scholarship recipient must not be on Academic Probation; however, Olgoonik Foundation may make a one-time only exception for extenuating circumstances.

If a scholarship is awarded, the full scholarship amount will be paid directly to the school to help cover the student’s eligible costs. If the student is unable to apply for a renewal scholarship by the deadline, funding may be withheld and the student will be solely responsible for all expenses.

If a student is unable to remain in good academic standing, the student may be placed on probation or have the scholarship revoked. If the student is placed on probation, has the

scholarship revoked, or does not complete the attempted credits for which funding was granted in that term, the student may be required to pay back the scholarship. Failure to comply with policies will result in a loss of funding.

APPLICATION INSTRUCTIONS AND GUIDELINES

1. **RENEWAL APPLICANTS:** You will need to declare your intent to continue school and verify the information provided in your initial paperwork has not changed. Renewal applicants must also supply the following:
 - a. Unofficial transcripts reflecting their last term's final grades
 - b. A copy of their upcoming course schedule with number of credits for the term clearly listed
 - c. An updated Budget Forecast for the current term. Students may use the Olgoonik-provided form or a Budget Forecast from his or her school, signed by the school's Financial Aid Officer. Budget Forecasts should reflect the student's *actual* costs for the term.
 - d. Agreement for Scholarship (signed after the scholarship has been approved by Olgoonik and before a check is sent to student's school)
2. **NEW APPLICANTS:** Submit the following documents with the attached application form:
 - a. Biological Family Tree and/or Adoptive Family Tree Form (attached)
 - Direct lineal descendants of an original Class A shareholder must submit birth certificate(s) or an adoption decree tracing ancestry back to an original Olgoonik shareholder
 - b. Degree Career Plan/ DegreeWorks Degree Audit, or document from the student's school detailing credit requirements and/or required courses for the student's degree program
 - c. Class Schedule with number of credits for the term clearly listed
 - d. Latest Official High School, College/University, or Trade School transcripts. Transcripts are considered official when received in an envelope that was sealed by the credit-awarding institution and arrive at Olgoonik unopened. Electronic transcripts are also accepted when sent directly to Olgoonik from the credit-awarding institution via a secured electronic transcript service
 - e. Three letters of recommendation which are no more than one year old and include contact information. Letters should be signed and should reflect evidence of good interpersonal and team skills. Letters may be from the following and no more than one letter can be a character reference.
 - School counselor, school principal, or class instructor
 - Former/present employer or supervisor
 - Former/present coworker
 - Character Reference from a family member, friend, whaling captain, or teammate
 - f. Submit a short essay (1-2 pages) describing your future plans and how you plan to use your education.
 - g. Budget Forecast (page 2 of application), completed by Financial Aid Officer. Students may use the Olgoonik-provided form or a Budget Forecast from his

or her school, signed by the school's Financial Aid Officer. Budget Forecasts should reflect the student's *actual* costs for the term.

- h. Agreement for Scholarship (signed after scholarship has been approved by Olgoonik and before a check is sent to student's school)
3. A completed application must be received prior to processing and award consideration. In the event final grades are not available from your school by the stated deadline, students will be required to submit final grades and transcripts within one week of their posting by the student's school. Failure to submit final grades by the deadline may result in denial of funding. All other application forms are due by the stated deadlines.

6. Ongoing or continuous students must adhere to the Academic Requirements to continue to receive funding.
7. Scholarship Deadlines are listed below. Completed applications must be received by the deadline date *prior* to the start of classes. For example, if a student's classes begin in September, the student must apply *before* the August 1 deadline.
