### Shareholder Youth of the Year

A shareholder 25 years or younger who has exhibited strong leadership for the “younger generation” and is an outstanding role model.

### Shareholder Leader of the Year

A shareholder, or descendant, who is an outstanding role model and exhibits dedication and commitment to Wainwright, Olgoonik, or Inupiat culture.

### Elder of the Year Award

A shareholder 65 years or older who is an outstanding role model and exemplifies the Inupiat values guiding our corporation.

## Nomination & Award Process

Nominations for each category must be made by completing the below Nomination Form. Submissions can be made in person at the OC offices in Wainwright in Anchorage or via email to [shareholderservices@olgoonik.com](mailto:shareholderservices@olgoonik.com).

In preparation for the Annual Shareholder Meeting, completed nominations will be accepted from January 1 to March 1 of each year.

Nominations will be processed by Shareholder Services Department personnel who will check nominee information and references. A 3-person committee will be convened by the Shareholder Services Department. The Committee will be provided the nomination forms with identifying information redacted and vote to select the most qualified nominee for each award category. Recipients will be announced at the Annual Shareholder Meeting.

Awards may include a trophy or plaque, gift certificates or other prizes, which can vary from year to year at the discretion of the Shareholder Services Department.

## Criteria for Nomination

Nominees must be in good standing with Olgoonik Corporation.

Nominees must be a Shareholder of Olgoonik Corporation.

The accomplishment(s) or contribution(s) to Olgoonik, Wainwright, or our Inupiaq Culture must be so outstanding that special recognition is required.

Board Members of Olgoonik Corporation are not eligible to receive this award.
